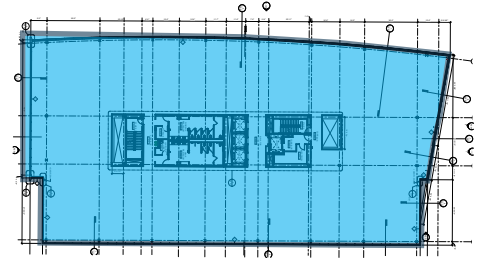

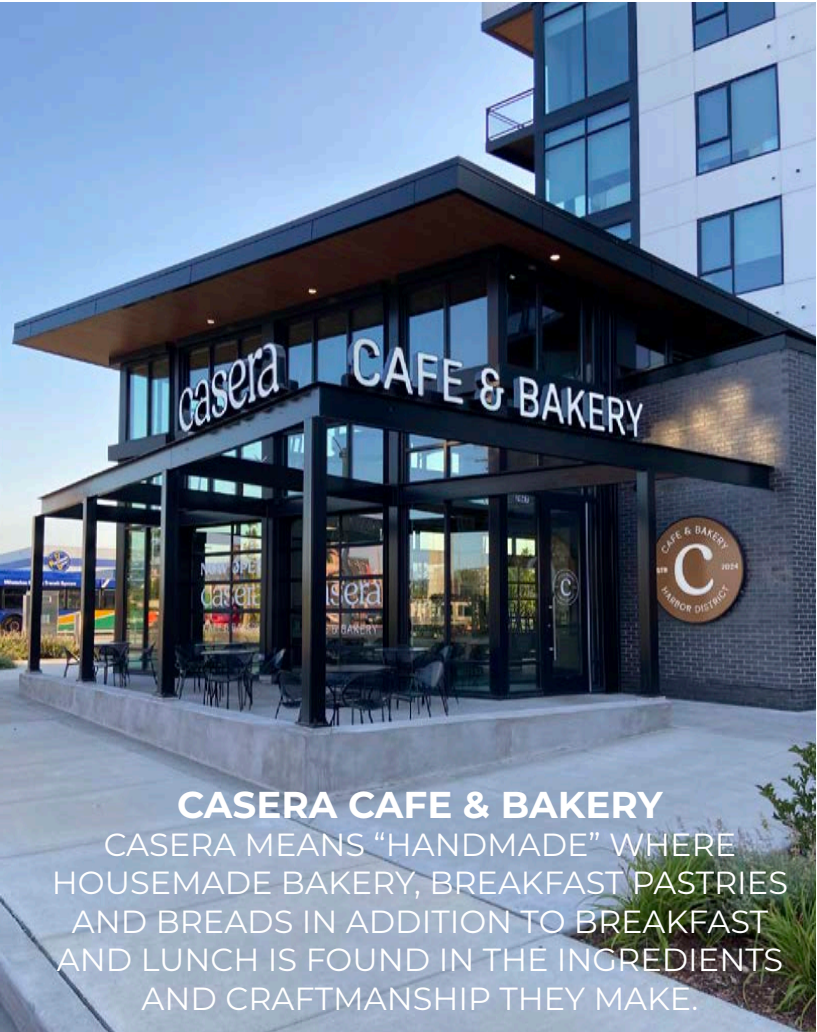
4TH & 5TH FLOOR COMBINE FOR 54,355 RSF

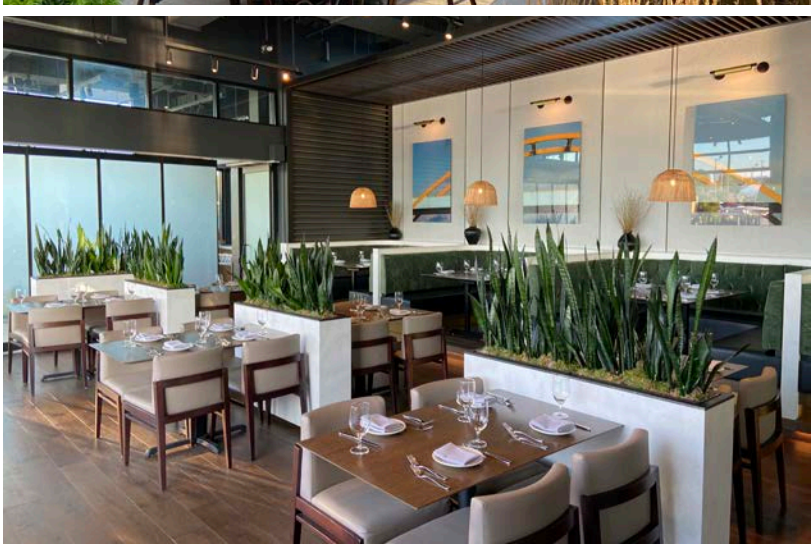

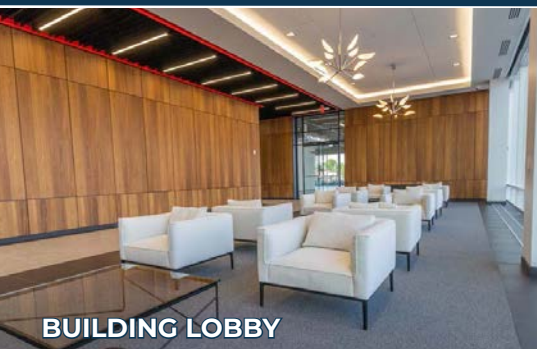
